



b) Managing Trustee

Mr. M. K. Dhamodharan shall be designated as the Chairman cum Managing Trustee, who shall be in charge of the day to day affairs of the trust. The Managing Trustee shall have over all power of Superintendence over the affairs of the trust.


c) First Trustees

The Founder Trustee and Executive Trustee shall hold office for life. d) Board of Trustees

All the trustees will be collectively known as Board of Trustees. Any person incompetent to contract cannot hold the office of the trustee.

- i) The Board of Trustees shall consist of the party of the First Part Shri. M.K. Dhamodharan Founder Trustee and Second part Smt. Nalini Dhamodharan Executive Trustee hereinabove mentioned as Trustees of the Board who shall hold the office upto their Life Time.
- The Founder Trustees has power to appoint as many trustees as required by them for the benefit and requirement of the Trust. At any time the number of Trustees in the Board of Trust shall not be less than Two and shall not be more than Six, provided, however, that the number of Trustees become less than required, the surviving or the continuing trustees shall be entitled to act with a view to appoint trustees so as to bring the number of trustees to the minimum as hereinabove mentioned.
- iii) The Founder/Board has the power to fill the vacancy by a resolution on the basis of retirement by rotation for every Three years.



e) Succession

In the event of any vacancy in the office of the Managing Trustee, by resignation or otherwise, the executive trustee as set out in point no .4(a) (2) above will be chosen as Managing trustee.

f) Cessation

The Chairman and Managing Trustee and the executive trustee shall hold office for his/her life.

The Other Trustees shall hold office for three years or until they cease to be the trustees for any of the following reasons.


- a. He/She is found to be unsound mind by a court of competent jurisdiction.
- b. He/She resigns his/her office as a trustee.

5. OBJECTS

a) Educational

- i) To organize, to start, to run or assist any school, college or other educational institutions or to help any educational institution for the benefit of the general public in all fields, whether engineering, technical, medical, management or any other field of study necessary and useful for the youth of the country.
- ii) To organize, start, run or assist any programme either by itself or by assisting or coordinating with other educational or other institutions for coaching, guidance and counseling or vocational training.
- iii) To run workshops, programmes, seminars etc. for the educated unemployed and the rural youth with or without coordination with other organizations.
- iv) To conduct training in computer and other skills in educational institutions or independently to provide such education.
- v) To give donations to educational institutions which are run on non profit basis subject to such conditions consistent with the objects of the trust.
- vi) To constitute scholarships to poor and deserving students to enable them to continue their studies and to give concession for fees and other charges including hostel fees or reimbursement of cost of books, instruments and other educational aids for their educational pursuits.
- vii) To help establishment of student's hostel or to give other assistance for poor and deserving students to find inexpensive living accommodation to enable them to carry on their studies.
- viii) To constitute prizes for outstanding achievements of students in educational institutions either in the examinations, sports, general knowledge or such other proficiencies.

- ix) To give loans at nil or subsidized low rate of interest to students to enable them to carry on higher studies.

- xii) To maintain, organize, run, manage, supervise, superintend, co-ordinate, affiliate, control, guide and aid patasalas, schools, colleges, universities, boarding houses, museums, laboratories and other educational institutions.






- iii) To establish and develop institutions for the physically handicapped, disabled and mentally retarded persons and to provide them education, foods, clothing and other help.

- iii) To work for the development of health, better sanitation, education, environment, social welfare and culture in rural areas.

 - v) Inculcating the habit of savings and thrift among women and youth.
 - vi) To promote agriculture and small-scale industries in rural areas on a co-operative basis
- vii) To organize various Sangam's and to establish welfare institution for women, youth and children in villages.
 - viii) To co-operate with other organizations doing the same line of social work.
 - ix) To secure co-operations of the government and public.
 - x) To promote cultural activities that will serve to enrich the lives of the people.


- xiii) To start memory centers with an aim of character building, personality development and orientation to social service.

6. Powers of Managing Trustee

- i) The Managing Trustee shall hold the properties of the Trust for the objectives stated hereinabove.
- ii) The Managing Trustee is entitled to open bank account or accounts in the name of the trust and the Managing Trustee is empowered to operate the account individually.
- iii). The Managing Trustee will have power to borrow, sign bills of exchange and authorize for this purpose any one or more of the trustees to exercise such power on his behalf by a resolution.
- iv) The Managing Trustee is entitled to borrow monies for the purpose of trust with or without security from banks, financial institutions or others and also have the power to effect any movable, immovable property or other funds of the trust as security.
- v) The Managing Trustee is entitled to appoint personnel for the purpose of the trust for carrying out the objectives of the trust and also fix the terms of employment and to dismiss or dispense with services of such personnel.
- vi) The Managing Trustee is entitled to appoint Chartered Accountants, Legal Advisors and such other professionals on such terms as the Board of Trustees deem fit from time to time.
- vii) The Managing Trustee is entitled to file suits on behalf of the trust and likewise defend any action taken against the trust and also compromise and compound such cases.
- viii) The Managing Trustee shall have the power to acquire assets for the purpose of the trust and likewise the power to dispose them off.
- ix) The Managing Trustee shall have power to convert the trust property, acquire immovable property, sell, charge, rent out or otherwise alienate the assets including immovable Property for protecting or improving the trust property or for any object of the trust.
- x) The Managing Trustee has the power to select, appoint or co-opt by unanimous resolutions additional trustees to the Boards of Trustees from time to time.
- xi) The Managing Trustee has powers to engage, suspend or dismiss employees or to take such other action to ensure proper management. It will have all powers necessary and incidental for management and administration of the trust and its properties.
- xii) The Managing trustee has the powers to arrange for and/or authorize the signing of or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustee/s by any one or more of the trustees to be nominated in this behalf by a

resolution at the meeting of the Board of Trustees and to make the same effective and binding, as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.

xiii) The Managing trustee has the power to constitute committees with specific purpose / assignments on the members of those committees shall be appointed by him for a specific period.

7. Powers of Board of Trustees

- i) Board of Trustees shall have the power to receive donations so as to augment the trust Funds or to treat such donations for the purpose of the trust either towards corpus or other funds eligible to be spent or applied according to the objects of the trust.
- ii) Board of Trustees shall have the power to invest the funds in best possible manner with a view to augment the resources of the trust to be able to better fulfill the objects of the trust, but the trust will not embark on any business or invest in any speculative venture. Such investments will also not deviate from the requirements of any law relating to public trusts or law relating to exemptions u/s 11 to 13 of the Income Tax Act.
- iii) Board of Trustees shall have the power to delegate their duties to any one of themselves or to employees, co-trustees and committees.
- iv) Board of Trustees may invite any employee, expert or well wisher to attend Trust Board meeting for advice and participation without right to vote.


8. Accounts



9. Amendment




- 10. The activities of the trust would be purely of charitable nature not motivated for profit.
- 11. The benefit of the object of the trust would be available to the general public irrespective of caste, creed, religion or sex.





- 12. The income of the trust shall not be applied for any religious purposes or given to any religious institution, except to the extent permitted or specified by the Income Tax Act, 1961 and the rules framed there under.
- 13. The activities of the Trust shall be only within India and its Union territories and shall not be extended anywhere outside India of this trust shall be confined to the territories of India.
- 14. The funds and income of the trust shall be solely utilized towards the objects of the trust and no portion thereof shall be utilized for payment to trustees or persons referred to in Section 13(1) (c) of the Income Tax Act, 1961, by way of profit or interest or dividends or in any other manner.
- 15. This trust is irrevocable.
- 16. The trust will be entitled to accumulate the income for the objects of the trust and to apply the same either out of the funds or the income for purposes of the trust to the extent considered prudent and necessary during the year in accordance with the provisions of Sections 11 to 13 of the Income Tax Act, 1961 and the statutory amendments thereof.
- 17. The trust, in the event of dissolution, the assets of the trust shall be handed over to such other trust or society or institution having objects similar to the trust and enjoying exemption u/s. 11 and recognition U/s. 80G of the Income Tax Act, 1961.
- 18. If any of the objects or any other provision is inconsistent with the character of the trust as a public charitable one either under the provisions of law and regulations relating to public charities or the law and the rules under direct laws relating to exemption of such public charitable trusts, now or as may be amended from time to time, such objects or provisions will be treated as non est in the trust deed and will stand omitted or modified so as to be consistent with such laws.
- 19. In the event of the trust not being able to function in fulfilment of its objects, the trustees shall, after discharging all liabilities, transfer the entire assets of the trust to any other public charitable institutions/institution having similar objects.
- 20. The Trustee is authorized to invest the funds of the trust in accordance with the section 11(5) read with the provisions of section 13(1) (d) of the Income Tax Act, 1961 and rules made there under from time to time.
- 21. The Trust shall not carry on any business for the trust with the funds of the trust other than a business which is permitted under the provisions of the Income Tax Act, 1961 nor would any of the funds or income of the trust inconsistent with section 13(2) of the Income Tax Act, 1961 or other persons with section 13





of the Income Tax Act, 1961 so as to directly or indirectly benefit such persons referred to in section 13 of the Income Tax Act, 1961.
